Dear Shri Oommen,

One of the key concerns in infrastructure projects relates to assuring quality as part of the overall project management. Quality in project implementation can be ensured by prescribing periodic inspections of the project by accredited inspection bodies to verify that quality and other parameters prescribed by the government are being met with in its execution. The Government may also directly engage the accredited inspection bodies and receive reports from them for follow up action.


2. The Quality Council of India (QCI) is an autonomous body under the Department of Industrial Policy & Promotion which is mandated to create a National Accreditation structure. As the national accreditation body, one of the accreditation schemes which QCI operates through its **National Accreditation Board for Certification Bodies (NABCB)** relates to **inspection bodies** as per applicable international standard, ISO 17020. An accredited inspection body implies that it is technically competent to carry out the inspection within the allotted scope under accreditation.


3. QCI could help in drafting a detailed system for inspection of infrastructure projects as per the requirements prescribed by the State Government. In this context it may be noted that the Government of Gujarat has recently announced a scheme on monitoring of quality outcome from government spending in the State on infrastructural projects, under which it has been prescribed that the inspection of project work shall be carried out only by NABCB (QCI) accredited inspection bodies.

QCI established in the year 1997 is governed by a Council comprising of 31 members.

NABCB is a member of IAF – MLA. Accordingly Certificates issued by Bodies accredited by NABCB are relied upon all over the World.
